The Cavalier Dismounted: An Essay on the Origin of the Founders of the Thirteen Colonies, by William H. Whitmore (Salem, 1864). Online: archive.org. A polemical essay from the genealogical politics of the Civil War, written months before the foundation of the Committee.

The Elements of Heraldry, by William H. Whitmore (Boston, 1866). Online: archive.org.

The first *systematic* book *explaining* heraldry to Americans, by someone who was, first and foremost, a genealogical researcher. Still very much worth reading.

Heraldic Journal, 4 volumes, Boston, 1862–1865. Published by the founding members of the Committee on Heraldry as a quarterly journal, in four volumes. Full of still-valuable research on early Americans' use of heraldry on seals, early gravestones, and in other contexts. Online at Hathi Trust: Heraldic Journal, vols. 1-2 (1865-66). William S. Appleton, "Positive Pedigrees and Authorized Arms," *Register* 45 (1891):<u>187-190</u>, with addenda at 52 (1989):<u>185</u>. A very short list of New England immigrants from English armigerous families; superseded by the *Roll of Arms* below.

The Balliol Roll (Boston, 2002). The earliest surviving manuscript collection of Scottish coats of arms, privately owned, published in a slim volume by the Committee.

A Roll of Arms Registered by the Committee on Heraldry of the New England Historic Genealogical Society

A register of coats of arms of immigrants to the American colonies or the United States, borne by right in their countries of origin (immigrants from the sixteenth to twentieth centuries from over twenty countries of origin). Project initiated 1914, publication began in 1928. Published in booklets and serially in the *Register* (links are to pages of the *Register* online at American Ancestors):

Sixth Part (379-450), published 1952, serialized in *Register* 107 (1953):<u>264-269</u> and 108 (1954):<u>31-36</u>. Seventh Part (451-522), published 1958, serialized in *Register* 112 (1958):<u>166-170</u> and <u>244-250</u>. Eighth Part (523-612), published 1972, serialized in *Register* 122 (1968):<u>3-10</u>, <u>94-99</u>, <u>179-184</u>; 125 (1971):<u>163-170</u> and <u>262-265</u>.

Ninth Part (613-684), published 1980, serialized in *Register* 133 (1979):<u>83-92</u>, <u>180-186</u>, and <u>271-279</u>. Tenth Part (685-741), not published as a stand-alone book; serialized in *Register* 145 (1991): <u>367-372</u>, and 146 (1992):<u>281-285</u>.

"Roll of Arms Registered by The Committee on Heraldry," Manuscript Roll, covering the First through Fifth Parts only (nos. 1-378, 1916-1945), with hand-painted arms and, often, details about the immigrant and the arms not in the printed *Roll of Arms* entries: image database at American Ancestors.

Modern Arms Recorded by the Committee on Heraldry of the New England Historic Genealogical Society

Modern arms have been systematically recorded by the Committee on Heraldry since 1936 (for assumed arms) and 1972 (for modern arms granted by foreign heraldic authorities, no longer added to the *Roll of Arms*). These records have not been systematically published until 2020, and are now published in the annual reports of the Committee:

American Works on Heraldry Not Connected to the Committee

- America Heraldica: A Compilation of Coats of Arms, Crests, and Mottoes of Prominent American Families Settled in this Country Before 1800, by E. de V. Vermont (New York: Brentano, 1886, with supplement and corrections, 1887). Online: archive.org. An imposing folio book with colored plates and some information about the families or immigrants and their arms, but often without any scholarly basis.
- Heraldry in America, by Eugene Zieber (Philadelphia, 1st ed., 1895, online: archive.org; 2d ed., 1909). The first (and last) encyclopedic book on heraldry for Americans, well-illustrated and still quite informative, but with no focus on a genealogical context, except on the topic of insignia (medals) worn by members of hereditary or lineage societies. Its introduction to civic and corporate heraldry is still very useful.
- *Crozier's General Armory: A Registry of American Families Entitled to Coat Armor*, by William Armstrong Crozier (New York, 1904). Online: archive.org. A national dictionary of bearers of coats of arms in colonial and more recent times. Entries are unsourced and must be independently verified.
- Matthews' American Armoury and Blue Book (London: Chas. Mitchell), 1903 edition, archive.org; and 1907 edition, archive.org. (Only two editions published?) A quasi-social register, produced in London but for Americans, with no citations to genealogical or other sources.
- Bolton's American Armory, by Charles Knowles Bolton (Boston, 1927). Online: hathitrust. A dictionary of Americans with coats of arms (but not illustrated) with emphasis on description of heraldic artifacts (antique or modern) belonging to specific individuals.
- Burke's Genealogical and Heraldic History of the Landed Gentry[:] Including American Families with British Ancestry, 16th ed., ed. L. G. Pine (London, 1939). Online: familysearch (opens to first page of American supplement, p. 2529). A massive three-thousand-page book of which the last 500 pages constitute an American supplement: the only one ever included in an edition of Burke's Landed Gentry. Most of the original color plate pages (American coats of arms are on plates numbered XI-LIV, bound before p. 2529) are viewable on this scanned copy on FamilySearch, but a few are missing. The American supplement was reprinted without the color plates as Burke's American Families with British Ancestry (Baltimore: GPC, 1977), and in this form is viewable as a database on Ancestry.
- Order of Americans of Armorial Ancestry: Lineages of Members, 2 vols. (Baltimore: GPC, 1997, 2013). [Not available online; see the organization's website here.] Includes lines of descent to members from qualifying ancestors deemed rightful bearers of coats of arms, with illustrations of the arms; no citations are included on the ancestors or the arms, so these lineage books have limited scholarly value.
- "Arms of Famous Americans: Presidents of the United States" by Joseph McMillan, at website of <u>American Heraldry Society</u>. Essays on sixteen U.S. presidents are case studies in various topics related to Americans' creation or appropriation of coats of arms, 18th to 20th centuries.
- "A Roll of Early American Arms" at the American Heraldry Society website: a visual index to entries found in the *Roll of Arms* and other books such as *Bolton's American Armory* and *Crozier's General Armory*.
